

PARENTAL CONSENT ADDENDUM

For Minor Contributors

Project Managed by The W.I.L.D. Company d.b.a. Queen Ex Literature (“Company”)

This Parental Consent Addendum (“Addendum”) supplements the **Contributor Agreement** between the Company and the **Minor Contributor (“Minor”)**, who is under the age of 18. This Addendum must be completed and signed by the Minor’s parent or legal guardian (“Parent/Guardian”) for the submission to be considered.

1. ACKNOWLEDGMENT OF AGREEMENT

By signing below, the Parent/Guardian acknowledges that they have reviewed, understood, and agreed to the full **Contributor Agreement** provided by the Company. The Parent/Guardian gives their consent for the Minor to:

- Submit creative work for publication, exhibition, or performance as part of the Project.
- Participate in all related editorial or creative correspondence (primarily by email).
- Be eligible for selection and potential compensation from the **Contributor Fund**.

2. PERMISSION TO PARTICIPATE

The Parent/Guardian grants permission for the Minor to:

- Have their work published, distributed, and promoted by the Company for up to **one (1) year** of exclusivity as described in the main agreement.
- Have their **name, likeness, and work excerpts** used in promotional materials (including digital, print, and live event formats).
- Receive payment directly (via check or direct deposit) or through the Parent/Guardian, as legally appropriate.

The Parent/Guardian understands that participation is voluntary and that the Company does not guarantee selection, compensation, or future opportunities.

3. EDITING & COMMUNICATION

The Parent/Guardian acknowledges that:

- Written works may undergo **up to three (3) editorial revisions**.
- All communication regarding edits and project participation will occur **by email**, unless otherwise scheduled by the Company.
- The Minor may be invited to a **debut event**, but attendance is optional.
 - Travel and lodging are the Parent/Guardian's responsibility unless the Minor is among the **top 50 artists** determined by social media votes, in which case lodging may be provided.

3.1 Mixed-Age and Mature Content Notice:

The Parent/Guardian understands that the Project includes contributors of various ages and experience levels, including adults who may create works exploring **mature, sensitive, or adult themes**. While the Company exercises editorial discretion to ensure that all content aligns with its artistic mission and complies with law, some published material may not be suitable for readers under 18.

By signing below, the Parent/Guardian acknowledges this and grants permission for their child's Work to appear within this environment.

4. RELEASE & WAIVER

The Parent/Guardian releases and holds harmless the Company, its representatives, and affiliates from any claims arising from the Minor's participation, including publication, event involvement, or promotional use.

This release includes consent to the Company's **non-AI use policy**—the Minor's submissions and data will not be used to train AI systems and will only be reviewed by real people.

5. REPRESENTATIONS

The Parent/Guardian represents that:

- They are the legal parent or guardian of the Minor named below.
- The Minor's submitted work is original and free from third-party restrictions.
- They have full authority to sign this Addendum and permit participation.

6. GOVERNING LAW

This Addendum is governed by the laws of the **State of California**. Any disputes will follow the procedures outlined in the main Contributor Agreement, including arbitration in **Los Angeles County, California**.
